B-Real is a personal website created to share selected thoughts, stories, photographs, articles and useful resources.

This Privacy Notice explains what personal information may be collected when you visit the site or contact me, and how that information is used.

Who is responsible for this website

This website is managed by Tony Bennett.

What information may be collected

B-Real may collect limited personal information in the following ways:

If you contact me by email

I will receive the information you choose to send, which may include your name, email address and anything included in your message.

If you visit the website

The website may collect basic technical information, such as your IP address, browser type, device information, pages visited and the date and time of your visit. This may happen through WordPress, hosting services, security tools or analytics tools.

If you access private pages

Some pages may be private or password protected for family use. If you are given access to these pages, I may know that access has been provided to you.

How your information is used

Personal information is only used for simple and reasonable purposes, including:

- replying to messages sent to me
- managing and protecting the website
- understanding how the website is used
- maintaining private family pages where appropriate

I do not use this website to sell services directly, and I do not use personal information from this site for marketing lists.

Cookies and website tools

This website may use cookies or similar technologies to help the site work properly, protect it from misuse, or understand basic visitor activity.

If analytics tools are used, they should be configured in a privacy-conscious way where possible.

You can usually control or delete cookies through your browser settings.

The ICO says websites must explain what cookies do and why they are used. Consent is required for non-essential cookies, such as many analytics or advertising cookies.

Who information is shared with

I do not sell personal information.

Personal information may be processed by trusted service providers that help run the website, such as:

- website hosting providers
- WordPress or website management tools
- security or backup tools
- email providers
- analytics tools, if used

These services may process information only as needed to provide their service.

How long information is kept

Email correspondence may be kept for as long as it remains useful or relevant, unless you ask for it to be deleted sooner and there is no good reason to keep it.

Basic website records, such as security logs or analytics data, are kept only for as long as needed for website management, security or reporting.

Your rights

Depending on the circumstances, you may have rights over your personal information, including the right to:

- ask what information is held about you
- ask for incorrect information to be corrected
- ask for information to be deleted
- object to certain uses of your information
- ask for use of your information to be restricted

The ICO explains that people should be told about their rights and how to raise concerns about the way their information is used.
